AHT role	Assistant Headteacher —oversees the daily running of their designated year groups. Has oversight of communication and support across the year group. They will offer advice and support to class teachers for parent queries.
SENDCO role	 Our Special Educational Needs and Disability Co-ordinator. Responsible for the SEND strategy and compliance with SEND Code of Practice. For children receiving Wave 1 support our SENDCO will have oversight of all SEND communication and support. Following the processes in the communication flowchart. Mrs Huxley will be contacted by class teachers and/or AHTS and involved at the right stage of support for the child. For children receiving Wave 2 or 3 support our SENDCO will provide professional guidance and support to colleagues and work with staff, parents, and other agencies to ensure that pupils with SEN receive appropriate support and high quality teaching Advise on the graduated approach to providing SEN support Ensure the school keeps the records of all pupils with SEN up to date
Inclusion	Daily monitoring of SEND email. Follows the procedures set out in the communication flowchart. Holds weekly
Administrator Role	meetings with SENDCO to review communication process and review all support tab entries
Local Offer	The Local Offer gives children and young people with special educational needs or disabilities and their families information about what support services are available in their local area.
ЕНСР	Educational Health Care Plan - Where a child requires additional support that goes beyond what a school, college, or nursery can typically deliver from their own budgets or staffing then they may need an Education Health and Care Plan (EHCP). An EHCP is a legally-binding document outlining a child or teenager's special educational, health, and social care needs. The document has to list all of the child's special educational needs, provision to meet each of the needs and that provision has to be specific, detailed, and quantified. The plan names the school/setting which is to provide the provision and the plan is legally enforceable ultimately through Judicial Review. Who needs an EHCP? EHCPs are for those children with special educational needs who require support beyond that which an educational setting can provide at SEN support.
